REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Parkways and Historic and Scenic Roads Advisory Committee, as established under Arizona Revised Statutes, Section 41-514, and acting in compliance with Rule R17-3-804, has made a thorough investigation concerning the designation of the Kaibab Plateau North Rim Parkway. State Route 67 from Jacob Lake to the north boundary of the Grand Canyon National Park was established as a state highway by the Arizona State Highway Commission in the official minutes of February 25, 1941 at page 133. In accordance with Arizona Revised Statutes, Section 41-514, the National Park Service agrees to the establishment of the Parkway over the North Rim entrance road from the park boundary to its terminus at Bright Angel Point. The Advisory Committee has reviewed, and recommends portions of the above-referenced roadways to be considered parkway and signed Kaibab Plateau North Rim Parkway.

The portion of roadway to be designated Kaibab Plateau North Rim Parkway begins on State Route 67 at Jacobs Lake (M.P. 580), thence southerly along State Route 67 to the north boundary of the Grand Canyon National Park; thence continuing in a southerly direction over the Park Service road to Bright Angel Point.

I concur with the Advisory Committee's recommendation. Accordingly, I recommend that the above-referenced portions of State Route 67 and North Rim entrance road be designated a parkway and signed the Kaibab Plateau North Rim Parkway.
