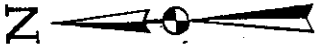

WHEREAS this Board finds that public convenience will be served by accepting the Director's report; therefore, be it

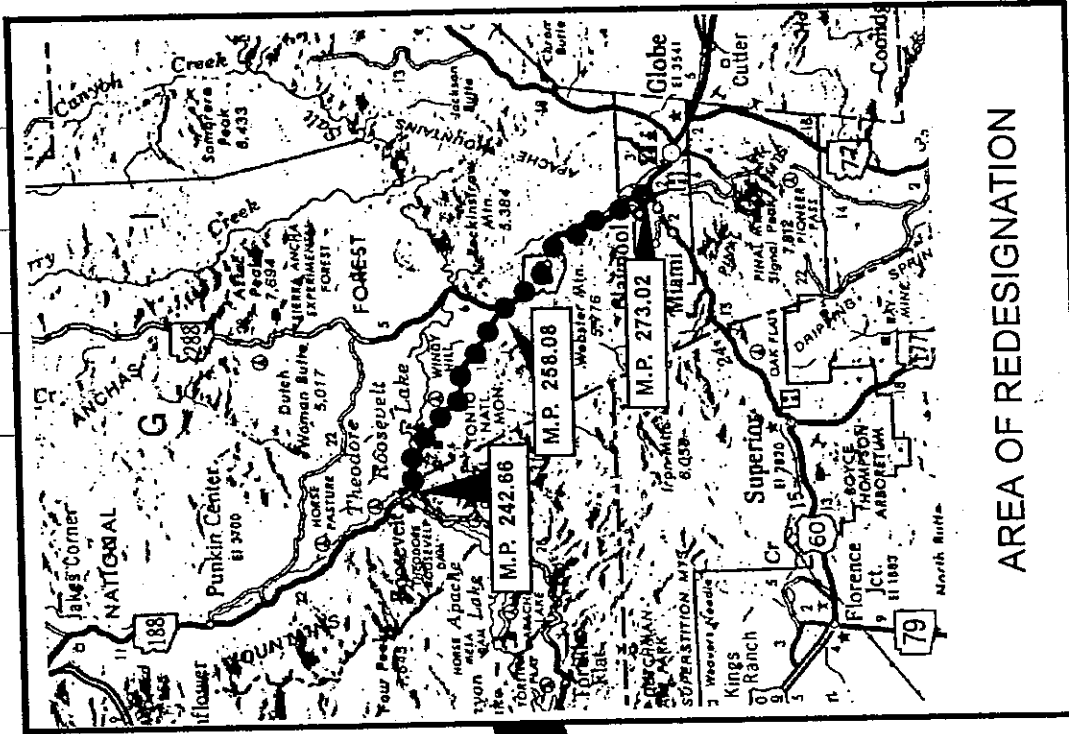
RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

RESOLVED that a portion of S.R. 88 is hereby redesignated and renumbered as S.R. 188.

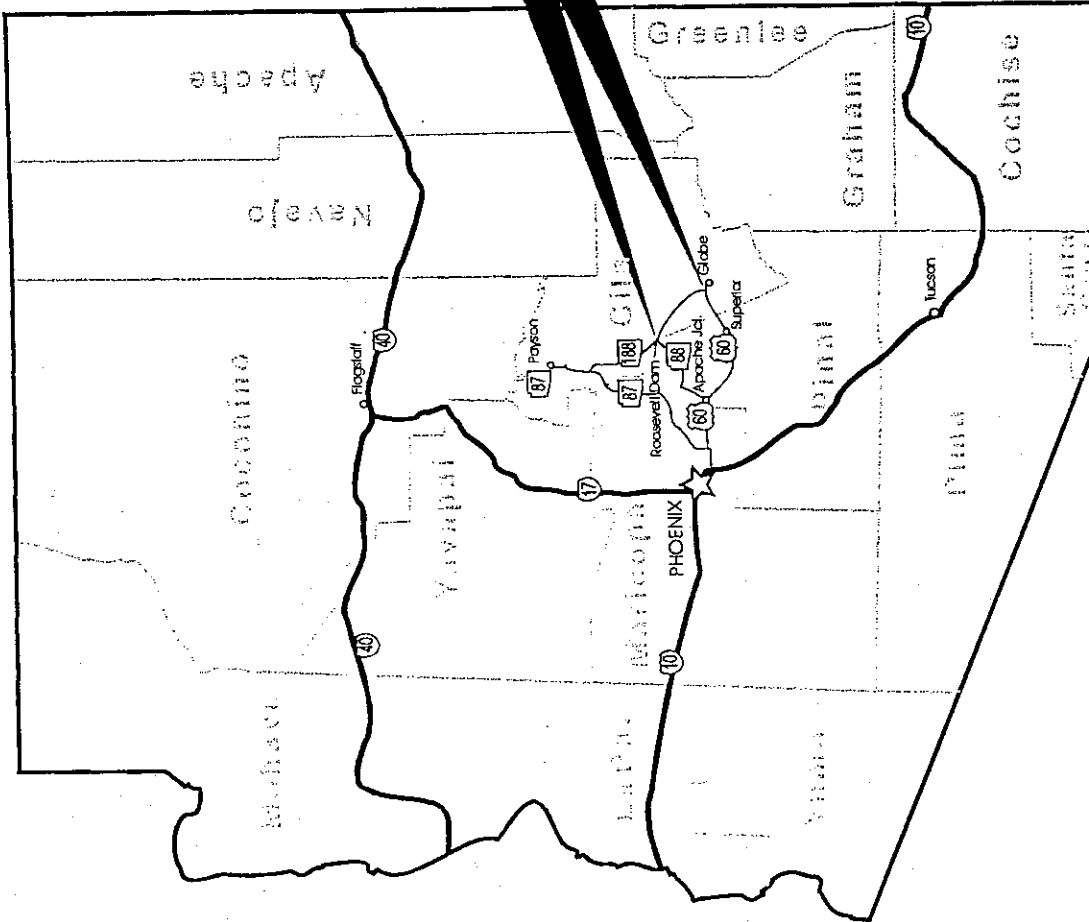

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the redesignation and renumbering of a portion S.R. 88 within the above referenced project. This portion was previously established as a state route and state highway by the Arizona Highway Commission Resolution dated September 9, 1927 at page 26 of the Official Minutes; and thereafter various Resolutions established additional right of way for improvements thereof.

The Globe District Engineer has requested that the Arizona Department of Transportation redesignate and renumber a portion S.R. 88 in order to accommodate the traveling public. The Intermodal Transportation Division and Transportation Planning Divisions have recommended approval of the Globe District Engineer's request. Accordingly, I recommend that a portion of S.R. 88 be redesignated and renumbered as S.R. 188.

The portion of existing state highway to be redesignated and renumbered is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona.


