

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the establishment of portions of State Route 96 and State Route 97 as state highways within the above referenced project.

These portions were previously established as state routes by Arizona Highway Commission Resolutions 62-142 and 62-143 both dated November 16, 1962.

Although the Department has been maintaining these alignments for several years with the inference that they were in the State Highway System, said alignments were never officially designated as state highways. Accordingly, it is now necessary to establish these portions of State Routes 96 and 97 as state highways in accordance with statutory requirements.

The portions of State Route 96 and State Route 97 to be established as state highways are depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, HILLSIDE-BAGDAD CONNECTING ROAD (S.R. 97) AND HILLSIDE - BAGDAD ROAD (S.R. 96) Highway, Project 370 (GEN) / 096YV000H088801R / 593 (GEN) / 097YV155H088801R."
