WHEREAS the portion of the above referenced state route to be designated Scenic Road NAAT'TIS'AAN Navajo Mountain Road is a state highway; and

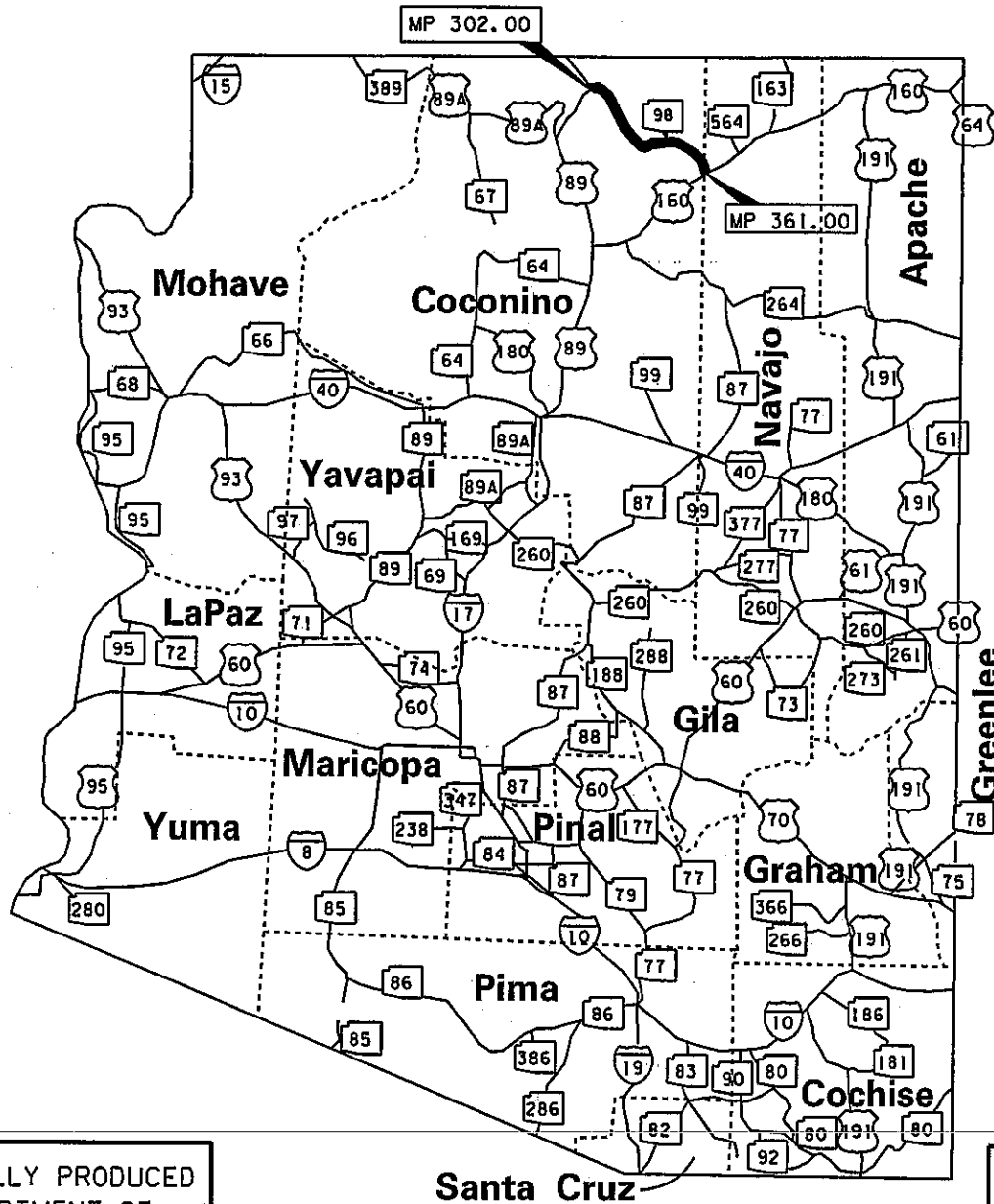

RESOLVED that the recommendation of the Director is adopted and made a part of this Resolution; be it further

RESOLVED that the portion of State Route 98, as depicted in Appendix "A", be designated a Scenic Road as defined in Arizona Revised Statutes Section 41.512(2); be it further

RESOLVED that this Scenic Road be designated Scenic Road NAAT'TIS'AAN Navajo Mountain Road.

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Parkways, Historic and Scenic Roads Advisory Committee, established under Arizona Revised Statutes Section 41-514 and acting in compliance with Rule R17-3-804, has made a thorough investigation concerning the designation of a portion of State Route 98 from Page (MP.302) to the U.S. 160 Junction (MP.361) as a Scenic Road.

This portion of existing state highway was previously designated by Arizona State Highway Commission Resolution 74-33, dated March 1, 1974 designating Indian Route 22 to State Route 98; thereafter Arizona Transportation Board Resolution 98-08-A-037, dated August 21, 1998 established additional right of way for improvements thereof.

The Advisory Committee has unanimously selected the route designation name of NAAT'TIS'AAN Navajo Mountain Road for this Scenic Road recommendation.

Therefore, the Advisory Committee has recommended that the portion of the above referenced highway be designated as Scenic Road NAAT'TIS'AAN Navajo Mountain Road as depicted in Appendix "A".

In the interest of public convenience and in concurrence with the Advisory Committee, I recommend that the above referenced portion of state highway, as depicted in Appendix "A", be designated Scenic Road NAAT'TIS'AAN Navajo Mountain Road.

Pursuant to Arizona Revised Statutes Section 41-514D, I recommend the adoption of a resolution making this recommendation effective.


